### **Other suggested items (for Pit members):**

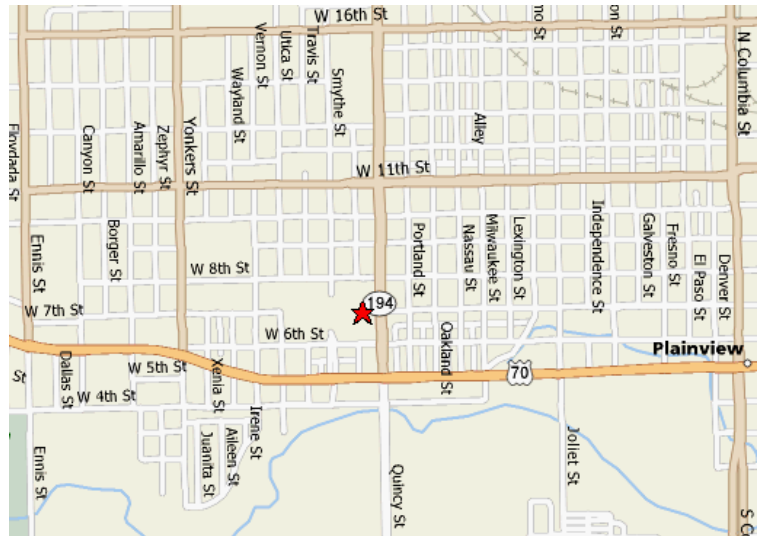
- Yarn Marimba mallets
